TERMS & CONDITIONS

Registration & Payment

- ✓ I agree to pay tuition, via one of two payment options, by the stated deadlines.
- ✓ When not paying in full (on September 1st), I will pay the \$50 administration fee.
- ✓ If payment is returned from the bank for any reason, a \$30 service charge will apply.
- ✓ If payment is made after a due date, an additional \$20 fee will be charged.
- ✓ Monthly fees will not be adjusted based on sick days, holidays or studio closures.
- ✓ Upon proper notification that your dancer has withdrawn from classes, fees will not be charged beginning on the 1st of the subsequent month.
- ✓ Costume payments are non-refundable.

Classroom/Studio Etiquette

- ✓ Parents/guardians are not permitted to enter the classroom during instruction unless invited by the teacher.
- ✓ Personal photos and videos taken at the studio are NOT to be shared through social media without permission.
- ✓ Dancers will only be permitted to leave class for reasons of emergency or with permission of the instructor.
- ✓ Parents/guardians must encourage dancers to use the washroom before class and supply a labelled water bottle for use during class.
- ✓ Proper dance shoes and attire are mandatory.

Photo Release

- ✓ Studio 12 is hereby granted permission to take photos & videos of the students to use in brochures, posters, advertisements, on the studio website or in other promotional material as well as the showcase/recital performance video. Permission is also hereby granted for the studio to copyright such photos in our name.

Lost/Stolen Items

- ✓ Studio 12 is NOT responsible for any missing items belonging to students or parents/guardians. It is strongly recommended that dancewear, shoes, water bottles, etc. are properly labelled.
- ✓ Valuable items should not be left unattended in the change room.
- ✓ Unclaimed items left in the studio will be held in the lost and found for 30 days. After this time, items will be donated.

Cancelling Classes

- ✓ If the studio is required to cancel classes due to an unexpected interruption, the missed lessons will not be rescheduled.
- ✓ The studio reserves the right to cancel, combine or reschedule any classes with low enrolment.

Release of Liability

- ✓ *In partial consideration for use of Studio 12 and its facilities, the undersigned, as Guardian of and on behalf of the child enrolled at Studio 12 and in their personal capacity, waives any and all claims, actions, damages, liability and expense against Studio 12, and any dance instructor(s) or choreographer(s) involved with or participating in any lesson, program, dance, practice, routine or competition through or at the Studio, in connection with loss of life, personal injury and/or damage to property arising from or out of any occurrence in, upon or at the Studio including loss of life, personal injury and/or damage to property arising from the child's participation in a dance routine, competition or practice at the Studio or any facilities or studios attended by the said child for the purposes of participating in a dance routine, competition or practice.*
